CHARACTERISTICS

Terylene B95 P2 GFC30 is a PBT injection molding grade, reinforced with 30% glass for rigid, high stiffnes and dimensional stable parts.

APPLICATIONS

Terylene B95 P2 GFC30 is used in a wide range of applications where a combination of mechanical properties, thermal resistance and dimensional stability are needed. This material is suitable for Food Contact applications.

Glass-fibre reinforced grades are suitable for housings, supports, covers, consoles and electrical insulating parts.

FORMAT AND STORAGE

Terylene B95 P2 GFC30 is supplied in moisture-proof packaging. Typical formats are Big Bag, octabin, and 25kg bags. All containers are perfectly sealed. The product should be stored in a dry place and opened just before processing.

PROCESSING GUIDELINES

Drying

Max. Water content: 0,04%

To ensure optimum part performance, this product should be dried prior to moulding and maintained at a moisture level of less than 0,04%. Dehumidifying dryers operating at 100-120°C for 4 hours drying time are recommended.

Injection moulding

The recommended processing parameters for injection moulding are:

Melt temperature: 250-280°C	Mould temperature: 60-100 °C
Injection speed: high	Back pressure: moderate

NOTE

All recommendations are based on knowledge and experience; The values have been established on standardized tests. The figures should be regarded as guide values and not as binding minimum values. As many factors may affect processing or applications, we recommend that customers make their own tests to determine the suitability of a product for its particular use.
